GUJARAT ACT NO. 1 OF 2014.

(First published, after having received the assent of the Governor, in the "Gujarat Government Gazette", on the 18th March, 2014).

AN ACT

further to amend the Gujarat Private Universities Act, 2009.

WHEREAS the Institute for Technology and Management (ITM Group), Mumbai had applied to the State Government under the provisions of the Gujarat Private Universities Act, 2009 to establish a Private University in the State;

AND WHEREAS the said application has been scrutinized by the Scrutiny Committee and on the report of Scrutiny Committee, the State Government has issued the letter of intent to the sponsoring body for establishment of the Private University;

AND WHEREAS the State Government is satisfied that the sponsoring body has complied with the conditions of letter of intent as provided in section 10 of the said Act and has also established the Endowment Fund as per the letter of intent;

NOW, THEREFORE, the Government of Gujarat, in accordance with the provisions of section 10 of the said Act, includes the institution specified in column 2 of the Schedule as the Private University, by the name, location and jurisdiction, of the aforesaid sponsoring body as specified in column 4 of the Schedule.

It is hereby enacted in the Sixty-fifth Year of the Republic of India as follows:-

Short title and

- (1) This Act may be called the Gujarat Private Universities 1. commencement. (Amendment) Act, 2014.
 - It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

In the Gujarat Private Universities Act, 2009, in the Schedule, after the Guj. 8 of 2009. Amendment of Schedule to Guj. entry at serial No. 13, the following entry shall be inserted, namely:-8 of 2009.

CHAPTER-I Grant of Approval for New Institution

Grant of Approval for setting up a "New Technical Institution" offering a Technical Education Programme(s) in Diploma/Post Diploma Certificate / Under Graduate Degree / Post Graduate Diploma / Post Graduate Degree / Post Graduate Certificate.

1.1 Introduction

- The New Technical Institution shall be established by providing Infrastructure and other requirements as per the norms specified in the Approval Process Handbook.
- b. New Technical Institution offering Technical Course(s) / Programme(s) shall NOT be established without prior approval of the Council.
- c. Admission Authority/ Body/ Institution shall not admit students to any Technical Programme of an Institution, which do not have requisite prior approval of the Council.
- d. The applications received by the Council shall be processed as per the norms and procedures specified in the Approval Process Handbook.
- e. The Institution shall also have to adhere to the existing Central, State and Local Laws and norms of other Regulatory Bodies also, if applicable.
- f. State Government / UT providing financial assistance for establishment of Technical institutions in order to offer the Technical Course (s) / Programs at DIPLOMA/UG/PG level. The Government must have requisite land for establishment of new institute.
- g. It is not mandatory for State Public, Private Universities and Central Universities to take AICTE approval as per the AICTE Act. However, Universities shall seek approval of AICTE for availing the benefits of AICTE Schemes/Initiatives as per the prevailing policies/norms to maintain the standards and norms as prescribed.
- Applications which were rejected and issued Final LoR in the previous academic year AY 2023-24 may apply afresh for approval as per applicable TER charges.

1.2 Timeline

- AICTE shall notify through a Public Notice in the leading newspapers and through AICTE Website from time to time, inviting applications along with detailed time-lines
- b. The submission of an application on AICTE Web Portal and payment shall not be later than the last date as notified in the Public Notice/ AICTE Website.

1.3 Application for Seeking Approval of the Council

1.3.1 To grant approval for establishment of a Technical Institution, online application on AICTE Web Portal through National Single Window System(NSWS) is mandatory. Application submitted offline shall NOT be accepted.

1.3.2 For Setting up a New Technical Institution proposed to offer a Programme in.

1TM Vocational University Campus : Plot 6512, Aiwa Nimata Road. institutions or other places of higher learning as equivalent to examinations or periods of study in the University and to withdraw such recognition at any time;

- v) To provide for automatic inter transfer mobility and uninterrupted program of study in all courses and programs as inter se between any and all Units of the Sponsor, ie the ITM group of Institutions, by transfer of credit, RPE, ROS etc
- w) To create industry academia partnership by inviting Industry in the University campus and other University centers for mutual benefits;
- To raise, collect, subscribe and borrow with the approval of the Board of Governors whether on the security of the property of the University, funds for the purpose and objectives of the University;
- y) To enter into, carry out, vary or cancel contracts;
- z) To create, amend and cancel the rules and regulations to fulfill the objective of the University;
- aa) To do all such other act or things whether incidental to the powers aforesaid or not, as may be necessary to further the objective of the University;
- bb) To carry out all such other activities as may be necessary or feasible in furtherance of the objective of the University;
- cc) To do all things necessary or expedient to exercise the above powers; and
- dd) The University shall have powers for collaboration and agreements of articulation and progression with reputed universities and institutions in India and abroad.
- ee) To collaborate with other recognized University, Research institutions, Industry, Government and Non-Government organization of the country and abroad towards the fulfilment of the University objectives.
- ff) To offer joint degree programs jointly with other degree granting institutions; both Indian and Foreign, provided that such institution(s) is / are properly accredited in their home country and with the prior approval of the state government and the UGC.

STATUTE No.06 FACULTIES and PROGRAMS

In exercise of the powers conferred vide Section 5(xi) of Chapter II of the Act, the University shall sponsor and undertake research and educational programmes in the fields of Science, Engineering, Technology, Vocational and Professional studies and training, Skill Development, Humanities, Social Sciences, Education, Management, Commerce, Law, Pharmacy, Health care and any other Allied areas under the following faculties:

- a) Faculty of Management, Economics & Commerce
- b) Faculty of Engineering and Technology
- c) Faculty of Life, Health and Allied Sciences
- d) Faculty of Vocational, Professional and Interdisciplinary Studies
- e) Faculty of Medical Sciences
- f) Faculty of Dental Sciences
- g) Faculty of Paramedical, Nursing and Allied Studies
- h) Faculty of Ayurveda, and Unani Medicine
- Faculty of Law

OFFICERS OF THE UNIVERSITY

Vide Section no 13 Chapter III of the act the following shall be the Officers of the University:

- a) The President;
- b) The Provost;
- c) The Registrar;
- d) The Chief finance and Accounts Officer;

In exercise of the powers conferred by the act vide the resolution of Adhoc Governing Body meeting held on 7th April 2014, the following shall be the Officers of the University:

- e) The Director General;
- f) The Vice President.

THE PRESIDENT

The President shall be the Head of the University under section 14(2) Chapter III of the act.

Term: The President shall be appointed by the sponsoring body, in consultation with the State Government, for a period of three years and further extension by following such procedure and on such terms and condition.

The President have the following powers:-

- a) To call for any information or record.
- b) To appoint the Provost.
- c) To remove the Provost in accordance with the provision of sub-section (6) of Ssection (15) Chapter-III of the Act.
- d) Such any other powers as may be prescribed by the Statutes or Act.

Functions:-

The President shall preside over the meeting of the Governing Body and at the convocation of the University for coonferring degrees, diplomas or other academic distinctions and in his absence by any other members of the Governing Body nominated by the President.

In the absence of the President due to illness or any other reason of specified or unspecified nature, the Governing Body of the Sponsoring Body shall authorize the Vice President or Provost or any other suitable persons to perform the duties of the President till the period as authorized and specified by the Board.

The salary and other benefits shall be determined vide the Statutes as with with the approval of the Governing Body
